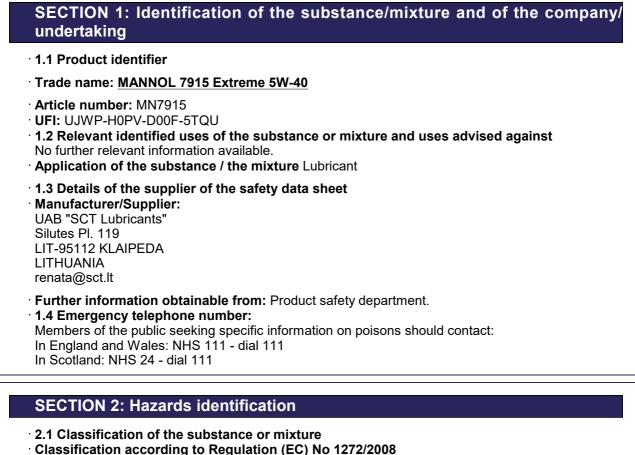

Protective gloves
